Contractor's Obligations:

The Contractor agrees to perform the Services personally and to the best of their skill and ability. The Contractor acknowledges that this contract does not create an employment relationship, partnership, or agency between the Contractor and the Employer. The Contractor shall comply with all relevant laws and regulations applicable to the provision of the Services.

Employer's Obligations:

The Employer agrees to pay the Contractor in accordance with the Payment Terms set out herein. The Employer shall provide reasonable access and facilities necessary for the Contractor to perform the Services.

Termination:

Either party may terminate this Contract at any time by giving reasonable notice to the other party. Termination may be immediate where there is a material breach of this Contract. Upon termination, the Employer shall pay the Contractor for all Services performed up to the date of termination.

Confidentiality:

The Contractor agrees that all information obtained from the Employer during the provision of Services shall be kept confidential and shall not be disclosed to any third party except as required by law.

Liability:

The Contractor shall indemnify and hold harmless the Employer against any claims, damages, losses, and expenses arising out of or resulting from the Contractor's performance of the Services, except to the extent caused by the Employer's negligence or breach of this Contract.

Governing Law and Jurisdiction:

This Contract shall be governed by and construed in accordance with the laws of England and Wales. The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim arising out of or in connection with this Contract.

Entire Agreement:

This Contract constitutes the entire agreement between the parties and supersedes all prior agreements, understandings, negotiations and discussions, whether oral or written, relating to its subject matter. No amendment or variation to this Contract shall be effective unless in writing and signed by both parties.

Severability:

If any provision of this Contract is held to be invalid, illegal or unenforceable for any reason, the remaining provisions shall continue in full force and effect as if the invalid, illegal or unenforceable provision had never been contained herein.

Force Majeure:

Neither party shall be liable for any failure or delay in performance under this Contract due to causes beyond its reasonable control including, but not limited to, acts of God, war, terrorism, civil disorder, strikes, epidemics, governmental actions, or failures of suppliers or subcontractors.

Assignments:

The Contractor shall not assign, subcontract or delegate any of its rights or obligations under this Contract without the prior written consent of the Employer. The Employer may assign this Contract without the Contractor's consent.
