

ACTORS CONTRACT AGREEMENT

PARTIES:

This Agreement is made between:

1. Production Company ("Producer"): _____
2. Actor ("Artist"): _____

1. ENGAGEMENT AND SERVICES:

Producer hereby engages Artist and Artist accepts engagement to render services as an actor in the production described herein, subject to the terms and conditions of this Agreement. Artist agrees to perform such services in a professional manner consistent with industry standards.

2. TERM:

This Agreement shall commence upon execution and shall continue for the duration of the production, including any promotional activities, unless earlier terminated pursuant to this Agreement.

3. COMPENSATION:

Producer shall pay Artist the agreed fee as full compensation for all services rendered under this Agreement. Payment shall be made according to the schedule set forth in Schedule A attached hereto.

4. RIGHTS GRANTED:

Artist hereby grants Producer the exclusive right to use Artist's name, image, likeness, and performance in connection with the production, including all media now known or hereafter devised, throughout the world in perpetuity.

5. CONFIDENTIALITY:

Artist agrees to keep confidential and not disclose any non-public information regarding the production, including scripts, storylines, and other proprietary information, except as authorized by Producer.

6. WARRANTIES AND REPRESENTATIONS:

Artist represents and warrants that Artist has the full right and authority to enter into this Agreement, that the services rendered will be original and do not infringe on any rights of third parties, and that Artist is not subject to any conflicting agreements.

7. TERMINATION:

Either party may terminate this Agreement for cause upon written notice if the other party materially breaches any term and fails to cure within a reasonable time. Upon termination, Artist shall be paid for all services rendered up to

termination.

8. INDEMNITY:

Artist agrees to indemnify and hold harmless Producer from any claims, damages, or liabilities arising from Artist's breach of this Agreement or violation of any law.

9. GOVERNING LAW AND JURISDICTION:

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties submit to the exclusive jurisdiction of the courts of England and Wales for any dispute arising out of or relating to this Agreement.

10. ENTIRE AGREEMENT:

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior negotiations, understandings, and agreements.

11. AMENDMENTS:

No amendment or modification of this Agreement shall be valid unless made in writing and signed by both parties.

12. SEVERABILITY:

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

13. NOTICES:

All notices under this Agreement shall be in writing and delivered by hand, recorded delivery, or email to the addresses set forth by the parties.
