Clause 1 – Agreement to Hire

The Owner agrees to hire the Vehicle to the Hirer, and the Hirer agrees to hire the Vehicle from the Owner, subject to the terms and conditions set out in this Agreement.

Clause 2 – Hire Period

The hire period shall commence and terminate on the dates specified above. The Hirer shall return the Vehicle to the Owner at the end of the hire period in the same condition, subject to fair wear and tear.

Clause 3 – Use of Vehicle

The Hirer shall use the Vehicle only for lawful purposes and in accordance with all applicable laws and regulations of the United Kingdom. The Vehicle shall not be used for any illegal activities, racing, towing, or carriage of passengers for hire.

Clause 4 – Hirer's Obligations

The Hirer shall be responsible for all costs, damages, fines, penalties, and expenses arising from the use or misuse of the

Vehicle during the hire period, including but not limited to fuel, tolls, congestion charges, and parking fees.

Clause 5 – Driver's Licence and Insurance

The Hirer confirms that they hold a valid United Kingdom driving licence appropriate for the Vehicle and shall provide proof upon request. The Hirer shall maintain valid insurance coverage for the Vehicle during the hire period as required by law.

Clause 6 – Deposit

The Deposit amount, if any, shall be held by the Owner as security for the performance of the Hirer's obligations under this Agreement and may be applied by the Owner to repair costs or other charges resulting from breach of this Agreement.

Clause 7 – Payment Terms

The Hirer shall pay the Hire Fee and any applicable Deposit to the Owner by the agreed method before or at the start of the hire period. Late payments may incur additional charges as specified above.

Clause 8 – Vehicle Condition and Inspection

The Vehicle is provided in the condition described above. The Hirer shall inspect the Vehicle before taking possession and report any existing damage to the Owner. Failure to report pre-existing damage shall be deemed acceptance of the Vehicle's condition.

Clause 9 – Maintenance and Repairs

The Hirer shall not perform or authorise any repairs or modifications to the Vehicle without the Owner's prior written consent. The Owner shall be responsible for routine maintenance and mechanical issues not caused by the Hirer's negligence.

Clause 10 – Liability and Indemnity

The Hirer shall indemnify and hold harmless the Owner from and against all claims, damages, liabilities, costs, and expenses arising from the Hirer's use of the Vehicle, except to the extent caused by the Owner's negligence or breach of this Agreement.

Clause 11 – Termination

The Owner may terminate this Agreement immediately if the Hirer breaches any term of this Agreement, uses the Vehicle unlawfully, or fails to make payments when due. Upon termination, the Hirer shall return the Vehicle immediately.

Clause 12 – Accident and Damage Reporting

The Hirer shall notify the Owner immediately of any accident, damage, theft, or loss involving the Vehicle and cooperate fully with any investigations or insurance claims.

Clause 13 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties submit to the exclusive jurisdiction of the courts of England and Wales.

Clause 14 – Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements, understandings, or representations. No amendments shall be effective unless in writing and signed by both parties.

Clause 15 – Notices

All notices under this Agreement shall be in writing and delivered by hand, post, or electronic communication to the

addresses provided by the parties.

Clause 16 – Severability

If any provision of this Agreement is found to be invalid or unenforceable, it shall be severed from the Agreement and the remaining provisions shall continue in full force and effect.

Clause 17 – Waiver

Failure or delay by either party to enforce any provision of this Agreement shall not constitute a waiver of that provision or any other rights.

Clause 18 – Force Majeure

Neither party shall be liable for any failure or delay in performing obligations caused by events beyond their reasonable control, including but not limited to acts of God, war, terrorism, or government restrictions.

Clause 19 – Data Protection

The parties agree to comply with all applicable data protection laws in relation to handling personal data obtained under this Agreement.

Clause 20 – Signatures

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which constitute one and the same instrument.
