1. Scope of Services

The Service Provider agrees to perform cleaning services as described above at the locations specified by the Client. The services shall be performed with reasonable skill, care, and diligence in accordance with industry standards.

2. Term

This Agreement shall commence on the date of execution by both parties and shall continue until terminated by either party in accordance with Clause 10.

3. Service Standards

The Service Provider shall ensure all work is performed in a professional manner, using appropriate cleaning materials and equipment. Any damage caused by the Service Provider shall be repaired or compensated accordingly.

4. Access to Premises

The Client shall provide the Service Provider with reasonable access to the premises during agreed service times and shall ensure the premises are safe and compliant with applicable health and safety regulations.

5. Health and Safety

Both parties shall comply with all applicable health and safety laws and regulations. The Service Provider shall ensure that all its employees and subcontractors are suitably trained and insured.

6. Confidentiality

The Service Provider agrees to keep confidential any information obtained during the provision of services, including but not limited to business, personal, and security information of the Client.

7. Liability and Insurance

The Service Provider shall maintain adequate public liability insurance and any other insurance required by law. Liability for any loss or damage arising from negligence shall be limited to the total fees paid under this Agreement.

8. Termination

Either party may terminate this Agreement by providing no less than 30 days written notice to the other party. Termination for cause may be immediate if there is a material breach not remedied within 7 days of written notice.

9. Force Majeure

Neither party shall be liable for any failure or delay in performance due to circumstances beyond their reasonable control, including but not limited to natural disasters, strikes, or governmental restrictions.

10. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties submit to the exclusive jurisdiction of the English courts for any dispute arising out of or in connection with this Agreement.

11. Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, understandings, and agreements relating to its subject matter.

12. Amendments

Any amendments or variations to this Agreement must be in writing and signed by both parties to be effective.

13. Notices

Any notices required under this Agreement shall be in writing and delivered by hand, registered post, or email to the addresses specified herein or as notified in writing.

14. Subcontracting

The Service Provider may not subcontract or assign any part of the services without the prior written consent of the Client.

15. Data Protection

Both parties shall comply with applicable data protection legislation in relation to any personal data processed under this Agreement.

16. Dispute Resolution

The parties agree to attempt to resolve any disputes amicably through good faith negotiations before resorting to litigation.

17. Severability

If any provision of this Agreement is found invalid or unenforceable, the remaining provisions shall remain in full force and effect.

18. Waiver

Failure to enforce any provision of this Agreement shall not constitute a waiver of that provision or any other provisions.

19. Counterparts

This Agreement may be executed in counterparts, each of which is an original but all of which together constitute one agreement.

20. Signatures

The parties have signed this Agreement indicating their acceptance of all terms and conditions stated herein.
