

CONSENT LETTER

To Whom It May Concern:

and confidentiality of my personal data and to protect it against unauthorized or unlawful processing, accidental loss, destruction, or damage.

8. International Data Transfers:

Should my personal data be transferred outside the United Kingdom, the data controller will ensure that adequate safeguards are in place in compliance with UK data protection requirements to protect my rights.

9. Complaints:

I am aware that I have the right to lodge a complaint with the Information Commissioner's Office (ICO) or other relevant supervisory authority if I believe that my data protection rights have been infringed.
