Clause 1 – Definitions

In this Agreement, the following terms shall have the meanings set out below unless the context requires otherwise: “Contractor” means the person or entity providing services under this Agreement; “Client” means the person or entity receiving the services; “Services” means the work to be performed by the Contractor under this Agreement.

Clause 2 – Scope of Services

The Contractor agrees to provide the Services described above with due skill, care, and diligence in accordance with applicable professional standards and all relevant laws and regulations of the United Kingdom.

Clause 3 – Term of Agreement

This Agreement shall commence on the date of execution and shall continue until completion of the Services or termination in accordance with this Agreement.

Clause 4 – Independent Contractor

The Contractor shall perform the Services as an independent contractor and nothing in this Agreement shall create a partnership, joint venture, or employment relationship between the parties.

Clause 5 – Payment

The Client shall pay the Contractor the Total Contract Price in accordance with the Payment Schedule set out above.

Payment shall be made within the agreed period following receipt of a valid invoice.

Clause 6 – Changes to Scope

Any changes to the Services must be agreed in writing by both parties. Any adjustment to the Contract Price or time for performance shall be agreed accordingly.

Clause 7 – Confidentiality

Each party agrees to keep confidential all information obtained from the other party in connection with the Services and not to disclose such information to any third party without prior written consent, except as required by law.

Clause 8 – Intellectual Property

Unless otherwise agreed in writing, all intellectual property rights arising from the provision of the Services shall be the property of the Contractor. The Client is granted a non-exclusive, non-transferable license to use any deliverables for its internal purposes.

Clause 9 – Liability and Indemnity

The Contractor shall indemnify and hold harmless the Client against all liabilities, damages, losses, and expenses arising out of the Contractor's negligence, breach of this Agreement, or wilful misconduct. The Contractor's total liability shall be limited to the amount of the Contract Price.

Clause 10 – Insurance

The Contractor shall maintain adequate insurance cover, including public liability and professional indemnity insurance, and provide evidence of such insurance upon request.

Clause 11 – Health and Safety

The Contractor shall comply with all applicable health and safety legislation and regulations and take all necessary precautions to protect the health and safety of persons involved in or affected by the Services.

Clause 12 – Termination

Either party may terminate this Agreement by giving written notice if the other party commits a material breach and fails to remedy such breach within a reasonable period. Termination shall be without prejudice to any accrued rights or liabilities.

Clause 13 – Force Majeure

Neither party shall be liable for any failure or delay in performing its obligations caused by events beyond its reasonable control, including acts of God, war, terrorism, strikes, or government action.

Clause 14 – Entire Agreement

This Agreement constitutes the entire agreement between the parties relating to the subject matter and supersedes all prior discussions, negotiations, and agreements.

Clause 15 – Amendments

Any amendments or variations to this Agreement must be in writing and signed by both parties.

Clause 16 – Notices

Any notices given under this Agreement shall be in writing and delivered by hand, prepaid post, or email to the addresses specified above or such other address as either party shall notify to the other.

Clause 17 – Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties

irrevocably submit to the exclusive jurisdiction of the courts of England and Wales.

Clause 18 – Dispute Resolution

The parties agree to attempt to resolve any disputes arising from this Agreement amicably. If unresolved, disputes may be referred to mediation or arbitration as agreed by the parties.

Clause 19 – Severability

If any provision of this Agreement is held invalid or unenforceable, the remainder of the Agreement shall remain in full force and effect.

Clause 20 – Counterparts

This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
