Contract Terms and Conditions:

1. Services Provided

The Carer agrees to provide domiciliary care services as described above, with due skill, care, and diligence, in accordance with all applicable laws and standards in the United Kingdom.

2. Term

This Agreement shall commence upon execution by both parties and continue until terminated in accordance with the termination provisions herein.

3. Carer Obligations

The Carer shall perform the services personally, maintain confidentiality, act in the Client's best interests, and comply with all relevant legal and professional requirements.

4. Client Obligations

The Client agrees to provide a safe working environment, necessary information for the provision of services, and to pay all fees in accordance with this Agreement.

5. Payment

The Client shall pay the Carer the agreed rate for hours worked, without deduction unless required by law. Payments shall be made in the agreed currency and frequency.

6. Termination

Either party may terminate this Agreement by providing written notice to the other party with a minimum notice period of seven (7) days, unless otherwise agreed.

7. Confidentiality

Both parties agree to keep confidential any information obtained during the course of this Agreement unless disclosure is required by law or agreed by the parties.

8. Liability

Neither party shall be liable for indirect, incidental, or consequential damages arising out of this Agreement. Carer's liability for direct damages shall be limited to the total fees paid under this Agreement.

9. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties submit to the exclusive jurisdiction of the courts of England and Wales.

10. Entire Agreement

This Agreement constitutes the entire understanding between the parties relating to its subject matter and supersedes all prior agreements and understandings.

11. Amendments

Any amendments or modifications to this Agreement must be in writing and signed by both parties to be effective.

12. Notices

All notices under this Agreement shall be in writing and delivered by hand, first-class post, or email with confirmation of receipt to the addresses provided by the parties.

13. Data Protection

The parties shall comply with all applicable data protection legislation in the United Kingdom, including but not limited to the UK GDPR and Data Protection Act 2018, in the processing of any personal data.

14. Health and Safety

Both parties shall comply with all applicable health and safety laws and regulations to ensure a safe environment during the provision of care services.

15. Equal Opportunities

The parties agree to comply with all applicable equal opportunities laws and shall not discriminate on any unlawful grounds.

16. Dispute Resolution

In the event of a dispute, the parties agree to attempt resolution through mediation before seeking recourse to the courts.

17. Independent Contractor

The Carer is engaged as an independent contractor and nothing in this Agreement shall create an employment relationship or partnership.

18. Insurance

The Carer shall maintain appropriate insurance coverage for the services provided, including public liability and professional indemnity insurance.

19. Subcontracting

The Carer shall not subcontract or delegate any of its obligations without the prior written consent of the Client.

20. Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in

full force and effect.
