such information to any third party without prior written consent.

**Clause 8 – No Collusion**

The tenderer declares that this tender is made without any connection, knowledge, comparison of figures, or arrangement with any other tenderer and is in all respects fair and without collusion or fraud.

**Clause 9 – Contract Award**

The tenderer acknowledges that the Contract may be awarded to the tenderer who provides the most economically advantageous tender as determined by the awarding authority.

**Clause 10 – Governing Law and Jurisdiction**

This tender and any resultant Contract shall be governed by and construed in accordance with the laws of England and Wales, and the parties submit to the exclusive jurisdiction of the courts of England and Wales.
