1. Guarantee

I, the undersigned Guarantor, hereby irrevocably and unconditionally guarantee to the Lender the due and punctual payment of all present and future liabilities and obligations of the Principal Borrower arising from or in connection with the loan or credit facilities granted by the Lender (the "Obligations"). This Guarantee is a continuing guarantee and shall remain in full force and effect until all the Obligations have been fully discharged.

2. Nature of Guarantee

This Guarantee is a primary obligation of the Guarantor and not merely a collateral or accessory undertaking. The Guarantor waives any right to require the Lender to proceed against the Principal Borrower or to enforce any other security before proceeding against the Guarantor.

3. Liability

The liability of the Guarantor under this Guarantee shall not be affected by any amendment, extension, renewal, or variation of the Obligations or any arrangement with the Principal Borrower or any other person. The Guarantor consents to any such amendment or arrangement without notice.

4. Payments

All payments under this Guarantee shall be made without any deduction or withholding for or on account of any taxes, levies, duties, or charges of any nature now or hereafter imposed, except as required by law, in which case the Guarantor shall pay such additional amounts as necessary to ensure the Lender receives the full amount it would have received had no deduction or withholding been required.

5. Waivers

The Guarantor waives any right of set-off, counterclaim, deduction, or defense arising from the Principal Borrower's obligations or any other matter. The Guarantor also waives any right to require the Lender to disclose any information relating to the Principal Borrower or the Obligations.

6. Continuing Guarantee

This Guarantee is a continuing guarantee and shall remain in effect notwithstanding any settlement or discharge of any

of the Obligations and notwithstanding any change in the constitution of the Lender, the Guarantor, or the Principal Borrower.

7. Governing Law and Jurisdiction

This Guarantee shall be governed by and construed in accordance with the laws of England and Wales. The Guarantor irrevocably submits to the exclusive jurisdiction of the courts of England and Wales for the purposes of any proceedings arising out of or in connection with this Guarantee.

8. Notices

All notices under this Guarantee shall be in writing and shall be deemed duly given when delivered by hand, sent by recorded delivery or registered post, or sent by email to the addresses specified by the parties.

9. Severability

If any provision of this Guarantee is found to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect to the fullest extent permitted by law.

10. Entire Agreement

This Guarantee constitutes the entire agreement between the parties in relation to the subject matter herein and supersedes all prior agreements, arrangements, and understandings relating thereto.
