Recitals:

WHEREAS, the Company engages the Introducer to introduce potential clients to the Company on the terms and conditions set forth in this Agreement; AND WHEREAS, the Introducer agrees to provide such introductions subject to the terms herein.

1. Appointment

The Company appoints the Introducer on a non-exclusive basis to introduce prospective clients to the Company in accordance with this Agreement.

2. Duties of the Introducer

The Introducer shall use reasonable endeavours to introduce potential clients to the Company, provide accurate information and not make any representations or warranties on behalf of the Company unless expressly authorized.

3. Introducer's Authority

The Introducer shall have no authority to enter into contracts or agreements on behalf of the Company or bind the Company in any way.

4. Fees and Payment

The Company shall pay the Introducer a fee calculated as specified in Schedule A attached hereto, payable within 30 days of the Company receiving payment from the introduced client. No other fees shall be payable unless agreed in writing.

5. Term and Termination

This Agreement shall commence on the date of execution and continue until terminated by either party giving 30 days written notice to the other party. Termination shall not affect accrued rights or obligations.

6. Confidentiality

Each party shall keep confidential all information obtained in connection with this Agreement and shall not disclose such information to any third party without prior written consent, except as required by law.

7. Data Protection

Both parties shall comply with all applicable data protection legislation, including the UK GDPR and Data Protection Act 2018, in relation to any personal data processed under this Agreement.

8. Compliance with Laws

The Introducer shall comply with all applicable laws and regulations in performing its obligations under this Agreement, including anti-bribery and anti-corruption laws.

9. Indemnity

The Introducer shall indemnify and hold harmless the Company from and against any losses, damages, liabilities, or expenses arising from any breach of this Agreement or negligence by the Introducer.

10. Limitation of Liability

Except in cases of gross negligence or willful misconduct, neither party shall be liable to the other for any indirect, incidental, consequential, or punitive damages.

11. Relationship of Parties

Nothing in this Agreement shall create a partnership, joint venture, or employment relationship between the parties.

12. Entire Agreement

This Agreement, including any schedules and annexes, constitutes the entire agreement between the parties and supersedes all prior discussions, agreements, or understandings.

13. Amendments

No amendment or variation of this Agreement shall be effective unless in writing and signed by both parties.

14. Notices

All notices under this Agreement shall be in writing and delivered by hand, sent by pre-paid recorded delivery, or email to the addresses specified above or such other address as notified in writing.

15. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties submit to the exclusive jurisdiction of the courts of England and Wales.

16. Severability

If any provision of this Agreement is held invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.

17. Counterparts

This Agreement may be executed in any number of counterparts, each of which shall be an original, but all of which together shall constitute one and the same instrument.
