## Clause 1 – Appointment and Services

Party A hereby agrees to provide lance services to Party B under the terms of this Agreement. Party A shall perform the services with due skill, care, and diligence in accordance with industry standards and applicable United Kingdom laws.

## Clause 2 – Term

The term of this Agreement shall be as specified in the 'Duration of Service' section. Neither party shall be bound beyond this term unless extended in writing by mutual agreement.

## Clause 3 – Payment

Party B agrees to pay Party A the fees set out in this Agreement. Payment shall be made in GBP by the agreed method within the specified timeframes. Late payments shall attract interest at the statutory rate applicable in the UK.

## Clause 4 – Obligations of Party A

Party A shall supply the lance in good condition and suitable for the specified purpose. Party A warrants that all equipment complies with relevant safety standards and regulations.

#### **Clause 5 – Obligations of Party B**

Party B shall ensure that all instructions and information necessary for Party A to perform the services are provided in a timely manner. Party B shall comply with all applicable laws and ensure safe access to the lance location.

#### **Clause 6 – Liability and Indemnity**

Each party shall be liable for loss or damage caused by its negligence or willful misconduct. Neither party shall be liable for indirect or consequential losses. Party B shall indemnify Party A against any claims arising from misuse of the lance or breach of this Agreement.

#### **Clause 7 – Termination**

Either party may terminate this Agreement by written notice if the other party commits a material breach and fails to remedy it within 14 days of notice. Termination shall not affect accrued rights or liabilities.

#### **Clause 8 – Confidentiality**

Both parties agree to keep all confidential information received under this Agreement private and shall not disclose it to third parties except as required by law or with prior written consent.

#### **Clause 9 – Force Majeure**

Neither party shall be liable for failure to perform due to causes beyond reasonable control including acts of God, war, terrorism, strikes, or governmental action. The affected party shall notify the other promptly.

#### **Clause 10 – Governing Law and Jurisdiction**

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties agree to submit to the exclusive jurisdiction of the English courts in respect of any dispute arising out of or in connection with this Agreement.

#### **Clause 11 – Entire Agreement**

This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements, understandings, and negotiations relating to its subject matter. Amendments must be in writing and signed by both parties.

#### **Clause 12 – Notices**

Any notice or communication required under this Agreement shall be in writing and delivered by hand, prepaid post, or email to the addresses specified in this Agreement or such other address as notified in writing.

#### **Clause 13 – Assignment**

Neither party may assign or transfer their rights or obligations under this Agreement without the prior written consent of the other party, except to a successor in title of the whole or substantially the whole of their business.

#### **Clause 14 – Severability**

If any provision of this Agreement is found to be invalid or unenforceable, the remainder shall continue in full force and effect and the invalid provision shall be replaced by a valid provision that most closely reflects the parties' original intention.

#### **Clause 15 – Waiver**

No failure or delay by either party to exercise any right shall operate as a waiver of that right. Any waiver must be in writing and signed by the party granting it.

#### **Clause 16 – Counterparts**

This Agreement may be executed in any number of counterparts, each of which shall be an original but all of which

together shall constitute one and the same instrument.

**Clause 17 – Data Protection**

Each party agrees to comply with applicable data protection laws including the UK GDPR in processing any personal data under this Agreement.

**Clause 18 – Health and Safety**

Both parties shall comply with all applicable health and safety legislation and regulations in connection with the performance of this Agreement.

**Clause 19 – Insurance**

Each party shall maintain adequate insurance coverage relevant to its obligations under this Agreement and provide evidence of such insurance upon reasonable request.

**Clause 20 – Dispute Resolution**

The parties shall attempt to resolve any dispute amicably through negotiation. Failing which, disputes shall be referred to mediation prior to any court proceedings.
