Clause 1 – Purpose of Agreement

This Agreement sets out the arrangements agreed between the parents regarding the upbringing and care of their child(ren). It is intended to be legally binding and enforceable under the laws of the United Kingdom.

Clause 2 – Parental Responsibility

Both parents acknowledge that they have parental responsibility for the child(ren) and agree to exercise their rights and responsibilities in the best interests of the child(ren).

Clause 3 – Child's Residence

The child(ren) shall reside primarily with Parent 1 / Parent 2 / as mutually agreed. Both parents shall provide suitable accommodation and care consistent with the child(ren)'s needs.

Clause 4 – Contact Arrangements

Parent 1 / Parent 2 shall have rights of contact with the child(ren) as agreed, including specific days, times, and holidays. Both parents shall facilitate and encourage a positive relationship between the child(ren) and the other parent.

Clause 5 – Education

The parents agree to jointly make decisions regarding the child(ren)'s education, including choice of school, extracurricular activities, and attendance. Both parents shall support the child(ren)'s educational development.

Clause 6 – Healthcare and Medical Decisions

Both parents shall be consulted on significant medical issues affecting the child(ren) and shall cooperate in making healthcare decisions. Emergency medical treatment may be administered by either parent when necessary.

Clause 7 – Financial Support

Both parents acknowledge their responsibility to financially support the child(ren). Details of financial contributions shall be agreed separately, including any child maintenance arrangements.

Clause 8 – Holidays and Special Occasions

The parents shall agree in advance on arrangements for holidays, birthdays, and other special occasions, ensuring the child(ren) spend meaningful time with both parents.

Clause 9 – Dispute Resolution

In the event of disagreements arising from this Agreement, the parents agree to attempt resolution through mediation or alternative dispute resolution methods before resorting to court proceedings.

Clause 10 – Variation of Agreement

Any amendments or variations to this Agreement shall be made in writing and signed by both parents to be effective.

Clause 11 – Confidentiality

The terms of this Agreement and any related information shall be treated as confidential and shall not be disclosed to third parties except as required by law or with mutual consent.

Clause 12 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of England and Wales.

Clause 13 – Execution

This Agreement is signed voluntarily and with full understanding of its terms by both parents, intending to be legally bound.
