Clause 1 – Purpose of Agreement

Seller agrees to sell and Buyer agrees to purchase the puppy described above (the “Puppy”) on the terms set forth herein. Seller warrants that it has full right, title, and authority to sell the Puppy and that no third party consent is required.

Clause 2 – Condition of Puppy

The Puppy is sold as healthy and free from any known contagious or infectious diseases at the time of sale. Buyer acknowledges having had the opportunity to examine the Puppy and accepts its condition as disclosed by the Seller.

Clause 3 – Health Records and Veterinary Care

Seller shall provide all veterinary health records, vaccination certificates, and any documentation related to the Puppy’s health history. Buyer is advised to obtain a veterinary examination upon taking possession.

Clause 4 – Seller’s Representations and Warranties

Seller represents and warrants that: (a) the Puppy is the lawful property of the Seller free from any liens or encumbrances; (b) the Puppy has been appropriately cared for; (c) all statements made regarding the Puppy’s health and

pedigree are true to the best of Seller's knowledge.

Clause 5 – Deposit and Payment

Buyer shall pay a deposit upon signing this Agreement, which shall be applied toward the Purchase Price. The balance shall be paid in full prior to or at the time of delivery. Payment methods acceptable to the Seller shall include bank transfer, cleared funds, or other agreed means.

Clause 6 – Delivery and Risk

Risk of loss or injury to the Puppy passes to Buyer upon physical delivery. Delivery shall be arranged by mutual agreement at a place and time specified by the parties.

Clause 7 – Return and Refund Policy

In the event that the Puppy is found to have a serious health condition at the time of delivery, Buyer may return the Puppy within 7 days for a full refund. Buyer must provide a written veterinary statement confirming the condition.

Clause 8 – Registration and Pedigree

Seller agrees to provide all necessary documentation to enable Buyer to register the Puppy with the relevant UK breed or kennel club, if applicable.

Clause 9 – Limitation of Liability

Seller's liability under this Agreement is limited to the Purchase Price paid. Seller shall not be liable for indirect, consequential, or incidental damages.

Clause 10 – Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties submit to the exclusive jurisdiction of the courts of England and Wales.

Clause 11 – Entire Agreement

This Agreement constitutes the entire understanding between the parties regarding the Puppy sale and supersedes all prior negotiations, representations, or agreements.

Clause 12 – Amendments

Any amendment to this Agreement must be made in writing and signed by both parties to be effective.

Clause 13 – Notices

All notices under this Agreement shall be in writing and shall be deemed duly given if delivered personally, sent by recorded delivery post, or email to the addresses provided by the parties.

Clause 14 – Severability

If any provision of this Agreement is held to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect.

Clause 15 – Counterparts and Electronic Signatures

This Agreement may be executed in any number of counterparts, each of which is an original and all of which constitute one agreement. Electronic signatures shall be deemed valid and binding.
