Recitals:

WHEREAS, the Parties have cohabited and mutually agree to live separately and apart without any intention to resume cohabitation; AND WHEREAS, the Parties wish to settle their respective rights and obligations arising from their relationship and separation amicably and conclusively;

1. Separation:

The Parties agree to live separate and apart on a permanent basis and cease to cohabit as partners. Neither Party shall interfere with the personal liberty or privacy of the other.

2. Property and Financial Arrangements:

The Parties acknowledge that they have agreed upon a fair and reasonable division of all joint and individual property, assets, and liabilities acquired during the relationship. Full particulars of such division are detailed in the attached Schedule A, which forms part of this Agreement.

3. Debts and Liabilities:

Each Party shall be responsible for their own debts and liabilities incurred before or after the separation, except as otherwise agreed in writing. Joint debts shall be settled as specified in Schedule A.

4. Custody and Care of Children:

If applicable, the Parties agree on arrangements regarding the care, custody, and financial support of their children, as detailed in Schedule B attached hereto.

5. Maintenance and Support:

Neither Party shall have any obligation to pay maintenance or support to the other unless otherwise agreed in writing or ordered by a competent court of law. Any such agreement shall be set out in Schedule C.

6. Confidentiality:

The Parties agree to keep the terms of this Agreement and any related negotiations strictly confidential and not disclose

such information to any third party except to professional advisors or as required by law.

7. Legal Advice and Independent Consideration:

Each Party warrants that they have had the opportunity to seek independent legal advice regarding this Agreement and enter into it freely, voluntarily, and with full understanding of its terms and legal effect.

8. Entire Agreement:

This Agreement, including all Schedules attached hereto, constitutes the entire agreement between the Parties and supersedes all prior agreements, representations, or understandings, whether oral or written.

9. Variation:

No variation or amendment to this Agreement shall be effective unless it is in writing and signed by both Parties.

10. Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The Parties submit to the exclusive jurisdiction of the courts of England and Wales to resolve any disputes arising out of or in connection with this Agreement.

11. Severability:

If any provision of this Agreement is held to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect, and the invalid provision shall be replaced with a valid provision that most closely reflects the Parties' original intent.

12. Execution:

This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
