Purpose of Sponsorship:

The Sponsor agrees to provide financial support to the Sponsored Party for the purposes set out in this Agreement. The Sponsored Party agrees to apply the sponsorship funds exclusively for the agreed activities and shall provide appropriate acknowledgement of the Sponsor as stipulated herein.

Clause 1 – Definitions

In this Agreement, unless the context otherwise requires, the following terms shall have the meanings ascribed to them: “Sponsor” means the Party providing sponsorship funds; “Sponsored Party” means the Party receiving sponsorship; “Agreement” means this Sponsorship Contract.

Clause 2 – Sponsorship Obligations

The Sponsor shall provide the agreed sponsorship amount according to the payment terms. The Sponsored Party shall use the sponsorship funds solely for the agreed purposes and shall provide evidence of expenditure upon reasonable request.

Clause 3 – Acknowledgement and Publicity

The Sponsored Party agrees to acknowledge the Sponsor in all relevant publicity, advertising, and promotional materials during the sponsorship period, as mutually agreed in writing.

Clause 4 – Term and Termination

This Agreement shall remain in effect for the specified sponsorship period unless terminated earlier by mutual written consent or upon material breach by either party, following the provision of written notice and a reasonable opportunity to cure.

Clause 5 – Intellectual Property

Nothing in this Agreement grants the Sponsor any rights to use the intellectual property of the Sponsored Party other than for acknowledgement purposes as agreed.

Clause 6 – Confidentiality

Both parties agree to keep confidential any information designated as confidential obtained in connection with this Agreement, except as required by law or agreed in writing.

Clause 7 – Liability and Indemnity

Each party shall indemnify and hold harmless the other party from any claims, damages, or losses arising out of their respective breach of this Agreement or negligent acts or omissions.

Clause 8 – Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties irrevocably submit to the exclusive jurisdiction of the courts of England and Wales for any disputes arising out of or in connection with this Agreement.

Clause 9 – Entire Agreement

This Agreement constitutes the entire agreement between the parties relating to its subject matter and supersedes all prior agreements or understandings, whether written or oral.

Clause 10 – Amendments

No amendment or variation of this Agreement shall be valid unless made in writing and signed by both parties.

Clause 11 – Notices

Any notice or other communication given under or in connection with this Agreement shall be in writing and delivered by hand, sent by post, or sent by email to the addresses provided by the parties.

Clause 12 – Force Majeure

Neither party shall be liable for any failure or delay in performance due to causes beyond their reasonable control, including but not limited to acts of God, war, terrorism, strikes, or governmental action.

Clause 13 – Counterparts and Electronic Signatures

This Agreement may be executed in any number of counterparts, each of which shall be an original, and all of which shall constitute one and the same instrument. Electronic signatures shall be deemed valid.

Clause 14 – Severability

If any provision of this Agreement is held to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect.

Clause 15 – Relationship of Parties

Nothing in this Agreement shall create any partnership, joint venture, agency, or employment relationship between the parties.

Clause 16 – Assignment

Neither party may assign or transfer its rights or obligations under this Agreement without the prior written consent of the other party.

Clause 17 – Waiver

No failure or delay by either party in exercising any right shall operate as a waiver of that right.

Clause 18 – Data Protection

The parties agree to comply with all applicable data protection legislation in relation to any personal data processed in connection with this Agreement.
