Photographer agrees to provide professional photography services as outlined below: Coverage duration, number of photographers, style of photography, number and format of edited images, delivery media, and any additional products or services. Client acknowledges that all specific service details and deliverables shall be confirmed in writing.

## Payment Terms:

Total fee for services is GBP \_\_\_\_\_. Client agrees to pay a non-refundable deposit of GBP \_\_\_\_\_ upon execution of this Agreement to secure the date(s). The balance shall be paid in full no later than \_\_\_\_\_ days before the event date(s). Payment methods accepted include bank transfer, cheque, or other methods agreed upon. Late payments may incur additional fees.

## Cancellation and Rescheduling:

Client may cancel or reschedule the event by providing written notice to the Photographer. The deposit is non-refundable but may be applied to a rescheduled date if agreed upon. Cancellations within \_\_\_\_\_ days of the event will incur additional fees as detailed in a separate schedule.

## Intellectual Property and Usage Rights:

Photographer retains the copyright to all images produced. Client is granted a non-exclusive, non-transferable license to use the delivered images for personal use only, including printing and sharing with family and friends. Commercial use, resale, or publication requires prior written consent and may incur additional fees.

## Limitations of Liability:

Photographer will perform services with reasonable skill and care. Liability for any claim, loss, or damage arising out of this Agreement shall not exceed the total amount paid by Client. Photographer is not liable for events beyond control including but not limited to adverse weather, equipment failure, or force majeure.

**Client Responsibilities:**

Client agrees to cooperate with Photographer and provide access to event locations. Client is responsible for obtaining any necessary permissions or permits. Client will ensure that guests behave appropriately and do not interfere with Photographer's work.

**Force Majeure:**

Neither party shall be liable for failure to perform obligations due to causes beyond their reasonable control, including but not limited to natural disasters, acts of God, war, terrorism, government restrictions, or pandemics. In such events, the parties shall negotiate a fair resolution.

**Confidentiality:**

Both parties agree to keep confidential any sensitive information obtained in connection with this Agreement and not disclose such information to third parties without prior written consent, except as required by law.

**Governing Law and Jurisdiction:**

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties hereby submit to the exclusive jurisdiction of the courts located in England and Wales.

**Entire Agreement and Amendments:**

This Agreement constitutes the entire understanding between the parties and supersedes all prior negotiations and agreements, whether oral or written. Any amendments or modifications must be made in writing and signed by both parties.

**Severability:**

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.
